3. **Discussion and possible approval to hire four (4) 42-hour transportation services personnel to assist with staffing levels, reduction in over-time costs, and help to decrease suppression personnel fill-in. (BOD #2017-09-03)**
4. **Update and presentation of realigned duties and organizational changes. (BOD #2017-09-04)**
5. **Discussion, consideration, and possible approval of the amendments to the Fiscal Year 2017/2018 Revenue and Expenditure Budget that was adopted at the July 19, 2017 board meeting and the possible adoption of Resolution 2017-07. (BOD #2017-09-05)**
6. **Call to the Public. (BOD #2017-09-n/a)**

A.R.S. §38-431.01(H) A public body may make an open call to the public during a public meeting, subject to reasonable time, place, and manner restrictions, to all individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter, or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.
