PURSUANT TO A.R.S. 38.431.02, NOTICE IS HEREBY GIVEN TO THE GENERAL PUBLIC THAT THE SUPERSTITION FIRE & MEDICAL DISTRICT ("SFMD") PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM ("PSPRS"), THE LOCAL PENSION BOARD HELD A MEETING ON TUESDAY, JULY 10, 2018. THE MEETING WAS HELD AT THE SUPERSTITION FIRE & MEDICAL DISTRICT'S ADMINISTRATION OFFICE, AT 565 N. IDAHO ROAD, APACHE JUNCTION, ARIZONA. THE MEETING WAS OPEN TO THE GENERAL PUBLIC AND BEGAN AT 4:15 P.M.

- A. Chairperson Gene Gehrt called the meeting to order at 4:15 p.m.

Motion by Local Board Member Briones to approve Amy Brooks' revised application to enter the DROP on 8/1/2018 and acknowledge that Amy must terminate employment with Superstition Fire & Medical District no later than 8/31/2023. Seconded by Local Board Member Geil. Vote 4 ayes, 0 nays. Motion passed.
