








Discussion and possible approval of State Wildland Fire Lease Agreement at the Regional Training Center (RTC).

State Fire currently wishes to lease 5,085 sq/ft at a cost of \$8 per sq/ft the district will earn \$3,390 monthly or \$40,680 annually.

The School District has requested 30% of our lease earning (\$12,200) based upon the above calculations. Resulting in \$28,480 in annual potential earning for the district

This Lease Agreement also incorporates an 18% per sq/ft utility usage charge. This allows the district to recover \$10,980 of utility costs.
