The following agenda items are scheduled for discussion at the board meeting. The Governing Board may or may not decide to take action on any or all items. The order of the agenda items may or may not be taken in the order listed.

1. Call to the Public. (BOD #2021-04)

A.R.S. §38-431.01(H) A public body may make an open call to the public during a public meeting, subject to a reasonable time, place, and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.

2. Possible vote to go into Executive Session for legal advice pursuant to A.R.S. § 38-431.03(A)(3) and for instructions to legal counsel pursuant to A.R.S. § 38-431.03(A)(4) regarding the terms of the final employment contract for the fire chief position; legal advice relating to pending personnel matters. (BOD #2021-04-01)

3. Discussion and possible direction regarding the terms of the final employment contract for the fire chief position. (BOD #2021-04-02)

4. Possible direction regarding pending personnel matters; application of discipline, hiring and promotional policy pending new fire chief appointment; transitions, rules and expectations. Possible instructions to management and staff relating to the logistics pertaining to the anticipated transition of the new fire chief. (BOD #2021-04-03)

5. Discussion and possible direction regarding the next meeting date. (BOD #2021-04-04)

6. Adjourn (BOD #2021-03-05)
