PURSUANT TO A.R.S. 38.431.02, NOTICE IS HEREBY GIVEN TO THE GENERAL PUBLIC THAT THE SUPERSTITION FIRE & MEDICAL DISTRICT ("SFMD") PUBLIC SAFETY PERSONNEL RETIREMENT SYSTEM ("PSPRS"), THE LOCAL PENSION BOARD HELD A MEETING ON TUESDAY, DECEMBER 7, 2021. THE MEETING WAS HELD AT THE SUPERSTITION FIRE & MEDICAL DISTRICT'S ADMINISTRATION OFFICE, AT 565 N. IDAHO ROAD, APACHE JUNCTION, ARIZONA. At the highest summary level, the report indicates the following key metrics for the consolidated PSPRS pension system:

- **A.** Funded percentage as of June 30, 2021: 54.2%, up from 46.9% (page 11/150)
- **B.** PSPRS received a clean audit opinion from Clifton Larson Allen LLP, their external audit firm (page 19/150)

This report provides the annual actuarial valuation of the Superstition Fire & Medical District's participation in the Arizona Public Safety Personnel Retirement System as of June 30, 2021, and applies directly to SFMD, with our current benefits and liabilities. NOTE: The contribution factors above are as of June 30, 2021 which is prior to the District's refinancing of its unfunded PSPRS liability. The actual Tier 1 & 2 Contribution rate is 14.50%, and the Tier 3 Contribution rate is 9.12%.
